Airport layout incorrect

Jeppesen Airport Moving Map and A816 formatted data for cycle 2405, effective 16 May 2023, contain incorrect data for Miguel Hidalgo Y Costilla Intl; Guadalajara, Mexico (MMGL).

Mexico AIP SUP 064/24, effective 16 May 2024, introducing updated AIP AD 2 MMGL pages (including Characteristics, Aerodrome Chart and Aircraft Parking/Docking Chart), was received after 2405 AIRAC cycle data processing due date, therefore the following changes, effective 16 May 2024, are not reflected in cycle 2405 data:

- Hotspot 1 note updated:
   "Landing aircraft on RWY 11/29 vacating on TWY C2, hold short of TWY A8."
- Hotspots 2 and 3 are removed
- RWY 02/20 is changed to TWYs C1 (between TWY P and RWY 11/29), C2 (between RWY 11/29 and TWY A8), C3 (between TWY A8 and TWY A), C4 (north of TWY A)
- TWY A4 (between TWY A and B, west of TWY A3) is added
- TWY B (east of TWY A5) is closed and name removed
- Unnamed TWY (between TWY A and TWY B) is closed and named TWY A3
- Closed pavement (between TWY A and TWY B) is changed to Taxiway and named TWY A4
- TWY A8 (between RWY 02/20 and TWY A11) is closed and name removed
- TWY A9 is closed
- Pavement (between RWY 02/20 and TWY A5) is added and closed
- Closed pavement (between TWY A1 and TWY A5) is removed
- TWYs A8 (east of RWY 02/20), K, C (south of TWY A), D (south of TWY A) are removed
- TWY L name is removed
